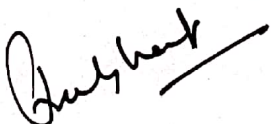

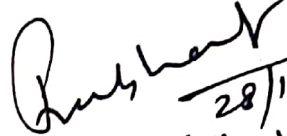

02. The officers who have already been given the benefit of 1st / 2nd / 3rd financial upgradation under ACP/MACP Scheme will not be entitled for the pay fixation benefit.
03. The above promotions are subject to the outcome of Hon'ble Supreme Court decision in Jarnail Singh Vs Lacchmi Narain Gupta case and other various cases pending in different judicial fora including decisions pending in W.P.C.T.No. 261/2008 filed by Shri Samiran Roy & Ors. Vs. U.O.I & Ors. before the Hon'ble Calcutta High Court and WP No. 7092/14, filed by Shri Rajkumar Jain & Ors before Hon'ble MP High Court, Jabalpur 200/293/2018, OA No.200/294/2018, OA No. 200/198/2018 and OA No. 1114/2019 pending before the Hon'ble CAT, Jabalpur
04. Under the provisions of FR 22(I)(a)(1), the promoted officers have to exercise their option for fixation of pay within one month of their promotion. They may further note that no request for condonation of delay in exercising the option shall be entertained.
05. The Commissioners concerned shall ensure that if any of the officers whose name has figured in table above to this order is under suspension or facing any charge sheet or prosecution, he/she should not be allowed to assume charge of post of Superintendent and this fact should be reported to this office immediately.
06. The posting of the officers promoted on in-situ basis is provisional . The above promotions does not confer any right upon them to retained at their present place of posting .
07. The promotion of officers who are currently on deputation/loan to other agencies/formations/SEZs shall take effect only after they are repatriated to their parent CGST, Customs & Central Excise Zone and report to their respective Commissioner's office immediately and not later than 10.01.2022 for joining the promotional post.
08. The promotion ordered now in subject to the condition that the officers shall join latest by 10.01.2022 failing which it will be treated that the officer has not accepted the promotion and all consequences arising as a result of non acceptance of promotion in terms of DP& AR OM No. 1/3/69-Estt(D) dated 22-11-75 as amended by DP & AR OM No. 22034/3/81-Estt(D) dated 1.10.1981 and DP & AR OM No. 22011/6/75-Estt(D) dated 30.12.1976 shall follow:
 - (I) No fresh offer of appointment shall be made to him for him for a period of one year or till a next vacancy arises whichever is later .
 - (II) On eventual promotion to the grade of Supdt., he will lose seniority vis-à-vis his junior promoted earlier.
 - (III) As per DOPT OM No. 35034/3/2008-Estt(D) dated 19.05.2009, the officer shall not be considered for further financial upgradation till he agrees to be



considered for promotion again and the next financial upgradation shall also be differed to extent of period of debarment due to refusal.

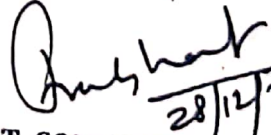
