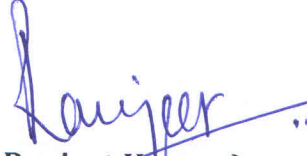
The following Inspectors of common cadre of Customs, CGST & Central Excise, Bhopal Cadre Control Zone are hereby promoted on regular basis, *in situ*, to the grade of Superintendent, CGST & Central Excise, Group 'B' Gazetted in the level 8 with Pay Matrix of Rs. 47,600 - 151000/- notionally with effect from 18.08.2017.

02. The promotion of Shri R.P Dwivedi and Shri P.R.Verma shall be notionally with effect from 18.08.2017 i.e from the date their juniors in the grade was promoted. The seniority of Shri R.P. Dwivedi and Shri P.R.Verma is fixed below Shri Omprakash Sirpurkar (promoted vide Estt. Order No.21/2018 dated 28.03.2018) and above Shri R. K. Wahane in the seniority list of combined cadre of Superintendent of Customs, CGST & Central Excise, Bhopal Zone, Bhopal.
05. The officers who have already been given the benefit of 1st / 2nd / 3rd financial up-gradation under ACP/MACP Scheme will not be entitled for the pay fixation benefit.
06. The above promotions will be subject to outcome of decisions pending in various judicial fora including decisions pending in W.P.C.T.No. 261/2008 filed by Shri Samiran Roy & Ors. Vs. U.O.I. & Ors. before the Hon'ble Calcutta High Court, OA No. 201/00097/14 dated 16.9.2014 filed by Shri Sandeep Karnik & Ors. before the Hon'ble CAT, Jabalpur and WP No. 7092/14, filed by Shri Rajkumar Jain & Ors. before the Hon'ble MP High Court, Jabalpur and OA No.200/325/2017 dated 21.4.2017 filed by the applicants before CAT Jabalpur.
07. Under the provisions of FR 22(I)(a)(1), the promoted officers have to exercise their option for fixation of pay within one month of their promotion. They may further note that no request for condonation of delay in exercising the option shall be entertained. It is made clear that the promoted officers shall not be entitled for any arrears and back wages except pay fixation benefits otherwise applicable under the extant rules.

08. The Commissioners concerned shall ensure that if any of the officers whose name has figured in table above to this order is under suspension or facing any charge sheet or prosecution, he/she should not be allowed to assume charge of post of Superintendent and this fact should be reported to this office immediately.
09. The seniority position of above promoted officers in the seniority list of Superintendent will be fixed as per DOP&T's O.M. No. 22011/1/2012-Estt.(D) dated 04.03.2014.
10. The posting of the officers mentioned above shall be on *in-situ* basis, till the time their regular posting orders are issued. The above promotion does not confer any right upon them to be retained at their present place of posting at later date when subsequent posting is decided.

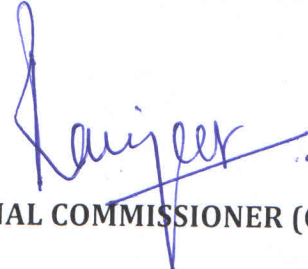
