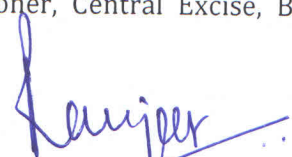

02. All the Officers will be promoted notionally with effect from 01.04.2018. The Seniority of Shri Achal Dubey is fixed above Shri Sharad Dohre and below Shri Ashish Kalra in the Seniority list of Superintendents. Similarly seniority of Shri Radha Mohan Vishwakarma is fixed above Shri Devendra Kumar Markam and below Shri Sharad Dohre. Officers from Sr. No. 3 to 9 of the above list will be placed below Shri Devendra Kumar Markam in the Seniority list of combined cadre of Superintendent of Customs, CGST & Central Excise, Bhopal Zone, Bhopal.
03. The officers who have already been given the benefit of 1st / 2nd / 3rd financial up-gradation under ACP/MACP Scheme will not be entitled for the pay fixation benefit.
04. The above promotions will be subject to outcome of decisions pending in various judicial fora including decisions pending in W.P.C.T.No. 261/2008 filed by Shri Samiran Roy & Ors. Vs. U.O.I. & Ors. before the Hon'ble Calcutta High Court, OA No. 201/00097/14 dated 16.9.2014 filed by Shri Sandeep Karnik & Ors. before the Hon'ble CAT, Jabalpur and WP No. 7092/14, filed by Shri Raj kumar Jain & Ors. before the Hon'ble MP High Court, Jabalpur.

05. Under the provisions of FR 22(I)(a)(1), the promoted officers have to exercise their option for fixation of pay within one month of their promotion. They may further note that no request for condonation of delay in exercising the option shall be entertained. It is made clear that the promoted officers shall not be entitled for any arrears and back wages except pay fixation benefits otherwise applicable under the extant rules.
06. The Commissioners concerned shall ensure that if any of the officers whose name has figured in table above to this order is under suspension or facing any charge sheet or prosecution, he/she should not be allowed to assume charge of post of Superintendent and this fact should be reported to this office immediately.
07. The seniority position of above promoted officers in the seniority list of Superintendent will be fixed as per DOP&T's O.M. No. 22011/1/2012-Estt.(D) dated 04.03.2014.
08. The posting of the officers mentioned above shall be on *in-situ* basis, till the time their posting orders are issued. The above promotion does not confer any right upon them to be retained at their present place of posting at later date when subsequent posting is decided.

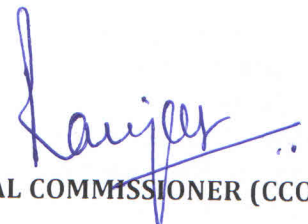
