If she fail to join her duties by the said date, it will be treated as her refusal to accept promotion and accordingly, her promotion order will be cancelled without any further notice. Consequently, she will not be considered for promotion in terms of Para 3 of 0.M.No.22034/3/81-Estt.(D) dated 01.10.81 for a period of one year or till the next vacancy arises, whichever event takes place later.
- 04. Under the provisions of FR 22(I)(a)(1), the promoted officer has to exercise her option for fixation of pay within one month of her promotion. She may further note that no request for condonation of delay in exercising the option shall be entertained.
- 05. The seniority position of above promoted officer in the seniority list of Senior Private Secretary will be fixed as per DOP&T's O.M. No. 22011/1/2012-Estt.(D) dated 04.03.2014.
