- 02. The specific postings within the jurisdiction of the Zone/Commissionerate will be made by jurisdictional Chief Commissioner/ Principal Commissioner/ Commissioner. While doing the postings, it shall be ensured that the existing policy of rotation to sensitive and non sensitive places shall be strictly adhered.
- 03. All the officers should ensure proper take over and hand over of charge. List of all urgent and time bound maters, pertaining to the important and necessary work should be prepared and handed over to the controlling officer and a copy of the same should be handed over to the officer taking over the charge by the officer handing over the charge. The officer should also make a note for the successor on issues of current importance, urgency of actionable points, critical issues as envisaged in DOP&T OM No. 13024/01/2014-TRG(Trg-Ref) dated 26.09.2014.
- 04. While doing posing, it shall be ensured that if any of the officers whose name has figured above is not clear from vigilance angle, he/she should not be posted to a sensitive charge as per vigilance policy.
- 05. All officers mentioned above must be relieved immediately and they should join at their new place of posting on or before **27.06.2017**. No representations whatsoever shall be entertained before they join at their new place of posting.
- 06. Officers whose names are mentioned at Sr. No. 45, 46, 51 to 54, & 57 to 62 are transferred on their own request hence they are not entitled for any joining time and transfer TA/DA etc.
- 07. Further, in partial modification of Estt. Order No. 216/2017 dated 09.06.2017, name of officer mentioned at Sr. No. 77 and Sr. No. 54 inter-alia are found to be same, hence ICT order mentioned at Sr. No. 77 may please be treated hereby as cancelled.
- 08. All the representations for inter-Commissionerate transfer in respect of Superintendents received till date has been disposed of accordingly.
