U.O.I. & Ors. before the Hon'ble Calcutta High Court, OA No. 201/00097/14 dated 7092/14, filed by Shri Sandeep Karnik & Ors. before the Hon'ble CAT, Jabalpur and WP No. OA No. 200/274/2018, OA No. 200/275/2018, OA No. 200/277/2018, OA No. 200/293/2018, OA No. 200/294/2018 and OA No. 200/198/2018.
- 04. Under the provisions of FR 22(I)(a)(1), the promoted officers have to exercise their option request for condonation of delay in exercising the option shall be entertained.
- O5. The Commissioners concerned shall ensure that if any of the officers whose name has figured in table above to this order is under suspension or facing any charge sheet or this fact should be reported to this office immediately.
