02. The officers who have already been given the benefit of 1<sup>st</sup> / 2<sup>nd</sup> / 3<sup>rd</sup> financial up-gradation under ACP/MACP Scheme will not be entitled for the pay fixation benefit.
03. The above promotions will be subject to outcome of decisions pending in various judicial fora including decisions pending in W.P.C.T.No. 261/2008 filed by Shri Samiran Roy & Ors. Vs. U.O.I. & Ors. before the Hon'ble Calcutta High Court, OA No. 201/00097/14 dated 16.9.2014 filed by Shri Sandeep Karnik & Ors. before the Hon'ble CAT, Jabalpur and WP No. 7092/14, filed by Shri Rajkumar Jain & Ors. before the Hon'ble MP High Court, Jabalpur and OA No. 200/00745/2016 filed by Shri Stephen Samuel before Hon'ble CAT, Jabalpur.
04. Under the provisions of FR 22(I)(a)(1), the promoted officers have to exercise their option for fixation of pay within one month of their promotion. They may further note that no request for condonation of delay in exercising the option shall be entertained.

05. The Commissioners concerned shall ensure that if any of the officers whose name has figured in table above to this order is under suspension or facing any charge sheet or prosecution, he/she should not be allowed to assume charge of post of Superintendent and this fact should be reported to this office immediately.

09. All the officers mentioned above must be relieved immediately and they must join at their new place of posting on or before 24.08.2017 under intimation to this office. No representations whatsoever shall be entertained before they join at their new place of posting. The respective Commissioners are requested to submit a consolidated joining/relieving report of the above officers to this office by 30.08.2017. All the representation received till date is disposed off accordingly.
