The following Senior Tax Assistant is hereby promoted to the grade of Inspector, Central Excise, Group 'B' non-gazetted in the Pay Level-7 of Pay Scale Rs. 44900-142400 (plus usual allowances as admissible) on notional basis with effect from 28.01.2015:-

- 02. The seniority of the officer will be fixed above Smt. V.S. Dolas and below Shri Vivek Kumar Chaubey in the seniority list of combined cadre of Inspector of Central Excise, Bhopal Zone.
- 03. The officer if already been given the benefit of 1st / 2nd Financial up-gradation under ACP/MACP Scheme will not be entitled for the pay fixation benefit.
- 04. The promotion of the officer mentioned above shall be on in-situ basis, till the time her posting order is issued. The above promotions does not confer any right to be retained at their present place of posting at later date when subsequent posting is decided.
- 05. The above officer should join her new post latest by 24/11/2017. If she fail to join her duties by the said date, it will be treated as refusal to accept promotion and accordingly, her promotion order will be cancelled without any further notice. Consequently, she will not be considered for promotion in terms of Para 3 of O.M.No.22034/3/81-Estt.(D) dated 01.10.81 for a period of one year or till the next vacancy arises, whichever event takes place later.
- 06. The above promotion is subject to the outcome various cases pending with different forum.
- 07. Under the provisions of FR 22(I)(a)(1), the promoted officer have to exercise her option for fixation of pay within one month of their promotion. She may further note that no request for condonation of delay in exercising the option shall be entertained.
- 08. The Commissioners concerned shall ensure that if the officer whose name has figured in table above to this order is under suspension or facing any charge sheet or prosecution, she should not be allowed to assume charge of post of Inspector and this fact should be reported to this office immediately.
- The seniority position of above promoted officer in the seniority list of Inspector will be fixed as per DOP&T's O.M. No. 22011/1/2012-Estt.(D) dated 04.03.2014.

- 10. The promoted officer should ensure proper take over and hand over of charge. List of all urgent and time bound maters, pertaining to the important and necessary work should be prepared and handed over to the controlling officer and a copy of the same should be handed over to the officer taking over the charge by the officer handing over the charge. The officer should also make a note for the successor on issues of current importance, urgency of actionable points, critical issues as envisaged in DOP&T OM No. 13024/01/2014-TRG(Trg-Ref) dated 26.09.2014
- 11. Consequent upon promotion, the promoted officer is nominated and directed to attend 'Induction Course for Inspectors', conducted by NACIN, Bhopal, scheduled to be held from 28.11.2017 to 19.01.2018 at Atal Bihari Vajpayee Institute of Good Governance & Policy Analysis, Sushasan Bhawan, Bhadbhada Road, T.T. Nagar, Bhopal - 462003. The respective Commissioner is requested to relieve the above said officer for 'Induction Course'.
- 12. The respective Commissioners are requested to submit a joining/relieving report of the above officer to this office by 30.11.2017.
