- O2. The additional requirement of officers at DGGI will be filled up separately on rotation basis as per recommendations of ADG, DGGI, Bhopal in consultation with respective commissionerates.
- 03. The specific postings within the jurisdiction of the Zone/Commissionerate will be made by jurisdictional Chief Commissioner/ Principal Commissioner/ Commissioner. While doing the postings, it shall be ensured that the existing policy of rotation to sensitive and non sensitive places shall be adhered to.

- 04. All the officers should ensure proper take over and hand over of charge. List of all urgent and time bound maters, pertaining to the important and necessary work should be prepared and handed over to the controlling officer and a copy of the same should be handed over to the officer taking over the charge by the officer handing over the charge. The officer should also make a note for the successor on issues of current importance, urgency of actionable points, critical issues as envisaged in DOP&T OM No. 13024/01/2014-TRG(Trg-Ref) dated 26.09.2014.
- 05 While doing posing, it shall be ensured that if any of the officers whose name has figured above is not clear from vigilance angle, he/she should not be posted to a sensitive charge as per vigilance policy.
- All officers mentioned above must be relieved on or before 25.5.2018.No representation 06, whatsoever shall be entertained before they join at their new place of posting. Any representation from the officers through proper channel will be entertained only after joining in new place of posting.
- All the representations for inter-Commissionerate transfer in respect of Superintendents 07. received till date has been disposed of accordingly.
- No transfer TA/Joining time will be admissible to the officer mentioned at Sr. No. 6 & 51 08. to 55 as he has been transferred on his own request.
- This issues with the approval of Chief Commissioner, Customs, Central Excise and 09. Central GST, Bhopal Zone, Bhopal.
