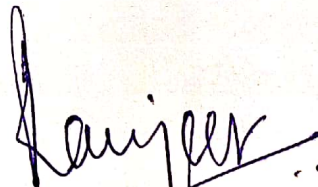

- i. Shri Gaurav Tiwari, Inspector posted in DRI, ZU, Indore has been granted extension for one year till next AGT.
- ii. Transfer of Shri Rishab Kumar Shrivastava (at Sl.No. 105 of EO No. 32/2019), Shri Harishanker Gurjar (Sl.No. 107 of EO No. 32/2019) and Shri Mayank Singh (at Sl.No. 120 of EO No. 32/2019) is hereby cancelled.
- iii. Shri Rajesh Gupta (at Sr.No. 139 EO No. 32/2019) and Shri Naindeep Chourasia (at Sr.No. 142 of EO No. 32/2019) are transferred from Audit Commissionerate, Bhopal to their respective postings. Shri Mayank Singh Rajawat (at Sl.No. 131 of EO No. 32/2019) is transferred from CGST Ujjain to the respective place.
- iv. Shri Amit Kumar-31.10.1989 is the officer transferred to ICD-Pithampur at Sr.No. 125 of EO No. 32/2019.

02. The specific postings within the jurisdiction of the Commissionerate will be made by jurisdictional Principal Commissioner/ Commissioner. The Chief Commissioner Nagpur Zone will allocate Commissionerate to the officers posted in Nagpur Zone. While doing the postings, it shall be ensured that the existing policy of rotation to sensitive and non sensitive postings shall be adhered to. **It may be ensured**

that no officer is posted in a sensitive charge for more than 3 years. While posting the officers, their station preference as per ICT Policy & history of posting may be duly considered. The jurisdictional Commissioner shall ensure that no officer is kept beyond 3 years in sensitive post in terms of Board's letter F.No.C 30013/79/2015-Ad.IVA(Vol.7) dated 17.7.2018.

03. While issuing posting orders, it shall be ensured that if any of the officers whose name has figured above is not clear from vigilance angle, he/she should not be posted to a sensitive charge.
04. The transferred officers should prepare a list of all important and time bound matters under their charge and handed over the same to the controlling officer with a copy to the officer taking over the charge. The officer handing over the charge shall also prepare a note for the successor in terms of DOP&T OM No. 13024/01/2014-TRG(Trg-Ref) dated 26.09.2014.
05. All the representations for transfer received till date have been disposed off. No representation whatsoever shall be entertained before they join at their new place of posting. Any representation from the officers through proper channel will be entertained only after joining in new place of posting.
06. No transfer TA/ Joining time will be admissible to the officers mentioned at Sr. No. 4 as he has been transferred on their own request.
07. All the transferred officers must be relieved on or before **07.06.2019**.
08. All the officers currently on deputation to DGCEI and DRI from this Zone shall be relieved on completion of their period of deputation as the competent authority has not extended their tenure beyond the period of deputation.
09. This issues with the approval of Chief Commissioner, Customs, Central Excise and Central GST, Bhopal Zone, Bhopal.

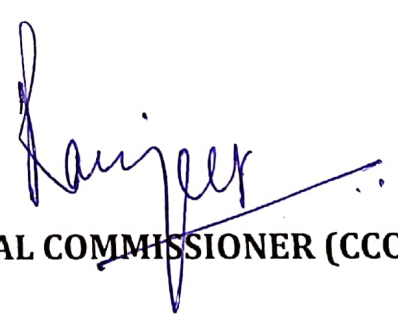
