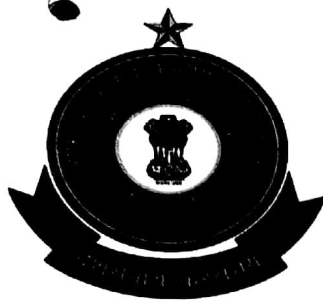

Consequent upon issuance of Office Order Nos. 107/2018 & 108/2018 (both) dated 03.07.2018 issued (under F. 2. The specific postings within the jurisdiction of the Commissionerate will be made by the jurisdictional Principal Commissioner/Commissioner. While doing the postings, it shall be ensured that the existing policy of rotation to sensitive and non sensitive places shall be adhered to.
3. All the concerned officers should ensure proper take over and hand over of charge. List of all urgent and time bound matters, pertaining to the important and necessary work should be prepared and handed over to the controlling officer and a copy of the same should be handed over to the officer taking over the charge by the officer handing over the charge. The officer should also make a note for the successor on issues of current importance, urgency of actionable points, critical issues as envisaged in DOP&T OM No. 13024/01/2014-TRG(Trg-Ref) dated 26.09.2014.
4. While doing posting, it shall be ensured that if any of the officers (whose name has figured above) is not clear from vigilance angle, he/she should not be posted to a sensitive charge as per vigilance policy.
5. All the representations for transfer in respect of Assistant/Deputy Commissioners received till date (noon) stand have been disposed of accordingly.
6. No transfer TA/Joining time etc. will be admissible to the officer at Sr. No. 4, as their transfer has been made as per his request.
7. The officer mentioned at S. No. 4 must be relieved on or before 20.07.2018. No representation whatsoever shall be entertained before they join at their new place of posting. Any representation from the officers through proper channel will be entertained only after joining in new place of posting.
8. All additional charge of Custom Indore may be treated as withdrawn. Further additional charge of Custom Indore, if required, may be forwarded to CCO by Commissioner Customs Indore.
