- The Chief Commissioner of Customs, Central Excise & Service Tax, Bhopal Zone (M.P. & C.G.), Bhopal will be Ex-Officio Chairman of this Committee and the Additional Commissioner (CCO), Bhopal Zone will be the Secretary of the Committee.
- 3. The functional of the above Committee will be purely advisory and the committee is intended for resolving procedural difficulties of general nature. They may however discuss any matter including policy behind individual cases, but exclude individual cases. No member other than the one already nominated can participate in the meetings.
- 4. The Committee will ordinarily meet once in three months or as often as the Chairman may decide. The meeting will be held at the Zonal Hqrs of the Chief Commissionerate or at some other Trade Centre within jurisdiction of the Chief Commissionerate, as decided.
- The nominated members of the Committee alone shall attend the RAC meeting. Any
 member who remain absent during three consecutive meetings without adequate

- reasons shall be deemed to have withdrawn himself from the Committee and his place shall be liable to be filled up by fresh nominee as may be selected by the Chairman.
- 6. All the members are requested to furnish agenda points proposed to be discussed in the RAC atleast 15 days before the date of meeting in writing through their jurisdictional Commissioners as well as through e-mail at cobhopal@gmail.com. The Trade Associations and Chambers of Commerce whose representatives have been nominated on the Committee are requested to ensure effective participation by the members.
