- 4. Vigilance Status/Certificate in terms of DOP&T OM dated 14.09.1992, as on 1.4.2003, 1.4.2004, 1.4.2005 & 1.4.2006 in respect of all the officers as mentioned above may please be provided.
- 5. In case of ACR/APAR of any officer for any particular period is missing/not reviewed/ not available for any reason such ACR/APAR should be supported by a "No Report Certificate" (NRC) which should be signed by the concerned Addl/Joint Commissioner (P&V) and countersigned by the Commissioner concerned in each case. It may kindly be ensured that if any of the ACR grading is found to be below benchmark for promotion (i.e. "Good"), the action according to DOP&T's instructions may be initiated, under intimation to this office.
- 6. The ACR grading for the period 1996-97 to 2004-05, CCR folder containing original ACRs for the period 1996-97 to 2004-05, Vigilance status, category of the above officers may be furnished to this office by 16th April, 2018 positively.
