OFFICE ORDER

Subject: Formulation of ICT policy in respect of Superintendent/Inspector of Bhopal Zone-reg.

The Inter-Commissionerate Transfer in the grade of Superintendents and Inspectors in the common cadre of Bhopal & Nagpur Zone currently governed by the Policy formulated on 30.10.2007. Consequent to Cadre Restructuring, new Commissionerate have come into existence in Bhopal/Nagpur Zones. It has therefore, become imperative to formulate a new Inter-Commissionerate Transfer Policy in respect of Superintendents & Inspectors of common cadre of Bhopal/Nagpur Zone.

2. It is pertinent to mention here that this office has formulated a Transfer Policy and circulated vide Circular No.01/2014 under C.No.II(03)08/CCO/BZ/2014/2397 dated 24.04.2014. However, the said policy was kept in abeyance till further orders.

3. To formulate a new policy, the Chief Commissioner, Bhopal Zone has constituted a committee consisting of following officers :-

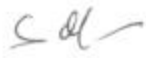
